If either output-enable input is high, the outputs of that 8-bit buffer section are in the high-impedance state.





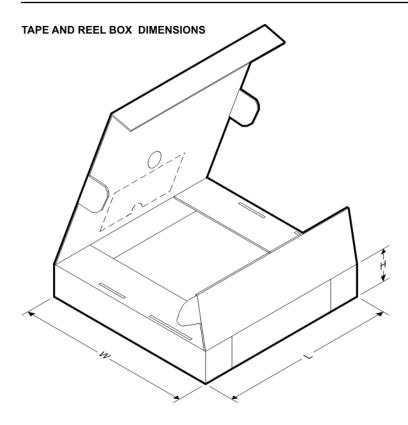
QUADRANT ASSIGNMENTS FOR PIN 1 ORIENTATION IN TAPE
