These devices can be used as four 4-bit buffers, two 8-bit buffers, or one 16-bit buffer. They provide inverting outputs and symmetrical active-low output-enable (\overline{OE}) inputs.





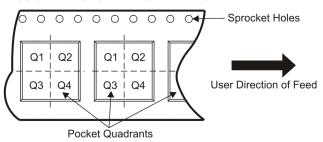
