

This triple 3-input positive-AND gate is designed for 2-V to 5.5-V V<sub>CC</sub> operation.

The SN74LV11A performs the Boolean function  $Y = A \cdot B \cdot C$  or  $Y = \overline{\overline{A} + \overline{B} + \overline{C}}$  in positive logic.

This device is fully specified for partial-power-down applications using I<sub>off</sub>. The I<sub>off</sub> circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.




